Splitting Lanes

Well I hope everyone is staying cool. Sorry I will not be at the meeting this month. I am going on a road trip to Maryland.

I just wanted to make a little note about an observation I had the other day with a group that was splitting lanes. We were all in the lane between the fast lane and the middle lane. Everything was fine until a couple of riders starting to split between the middle and the slow lane. What happened next could have been a disaster. The car in the middle saw the bike on his right and moved over to the left and almost hit the rider on his left. When we are in group splitting lanes stay with the group.

California becomes first state to legally recognize lane splitting

Gov. Brown signs A.B. 51, directing California Highway Patrol to draft guidelines August 19, 2016

PICKERINGTON, Ohio – Gov. Jerry Brown signed A.B. 51 into law today, making California the first state to legally recognize lane splitting, the practice in which motorcyclists ride between lanes of traffic.

The bill, sponsored by Assemblymembers Bill Quirk (D-Hayward) and Tom Lackey (R- Palmdale), grants the California Highway Patrol the authority to develop and issue lane-splitting guidelines in consultation with motorcycle safety groups and riders.

"This is great news for motorcyclists in California and throughout the country," said Rob Dingman, president and CEO of the American Motorcyclist Association. "The California Assembly and the governor have taken a huge step in formally recognizing a practice that has been is use for decades.

"Lane splitting keeps riders safer by eliminating their exposure to rear-end collisions, and it helps ease congestion by effectively removing motorcycles from the traffic lanes."

Studies by the University of California at Berkeley show that splitting lanes is a relatively safe maneuver when both the motorcyclist and nearby drivers know the law and adhere to safe and prudent driving practices.

In 2012, the CHP developed guidelines for splitting lanes, posting them online in 2013 and including them in the Motorcycle Handbook distributed by the Department of Motor Vehicles. However, a citizen complained in 2014 that the guidelines were "underground regulations" put together by a state agency, rather than the legislature. So the CHP and DMV removed them.

A.B. 51 clarifies that the CHP does have authority to develop educational guidelines on lane splitting. The law also removes the practice from the legal gray area, where it was neither expressly prohibited nor approved.

Several other states, including Nevada, Georgia, Washington, Oregon and Texas, have considered legislation during the past two years that would have made lane splitting legal, with certain restrictions.

"We hope that other states will follow California's lead on this issue," Dingman said. "The AMA is here to support individuals, groups and legislators who want lane splitting made legal in their states, too."

POLICE MOTORCYCLES AND HARLEY-DAVIDSON A Short History

The history of Harley-Davidson Police and Fleet sales is long and rich — and almost as old as the Motor Company itself. Before there was even a commercially produced Harley-Davidson V-Twin, policemen were patrolling on Harley-Davidson® motorcycles. Through the economic ups and downs of the Motor Company's history, the police and fleet businesses have helped keep the Harley-Davidson brand alive.

THE BEGINNING

The first Harley-Davidson police motorcycle was delivered to the Detroit Police Department in 1908. Right from the start, police departments recognized the tactical advantage provided by a maneuverable vehicle such as a motorcycle along with Harley-Davidson's reputation for reliability.

THROUGH THE TEENS

Harley-Davidson motorcycles accompanied General John J. "Black Jack" Pershing in pursuit of Pancho Villa after he attacked Columbus, NM in 1916. Harley-Davidson motorcycles proved their value as military hardware. Shortly after the Mexican foray, the U.S. was drawn into World War I – as were approximately 20,000 Harley-Davidson motorcycles. Motorcycles were a great aid in dispatching messages before the advent of reliable radio communications. Most of these motorcycles had sidecars which could be fitted with machine-gun mounts if needed.

THE ROARING '20S

Back on the home front in the 1920s, state police forces were being formed in several states to protect rural areas from lawlessness and to enforce Prohibition. The motorized vehicle of choice on rutted rural roads was the motorcycle. In 1921, six troopers kick-started their Harley-Davidson motorcycles and the Washington state troopers were in business. In those days, considering the territory officers had to cover, a motorcycle needed to be reliable. In Louisiana, for example, a force of just 16 men on motorcycles patrolled the entire state.

By 1920, Harley-Davidson was the largest motorcycle manufacturer in the world. As mass production increased the numbers of cars and motorcycles on the road, and most speed limits were not enforced, highway fatalities skyrocketed. In 1926, a special office for fleet sales to law enforcement was established. Harley-Davidson published the goal of helping law enforcement "curb this tragic traffic slaughter." Being faster and more maneuverable than most cars on the road, Harley-Davidson motorcycles gave police the upper hand against speeders. By the end of the 1920s, more than 3,000 police departments and government agencies used Harley-Davidson motorcycles.

At our first poker stop, some members of another group mentioned their appreciation of what they called "group sense" in my leading. I had no idea what that meant, so asked. It was that when we came to a stop sign, or a gap
