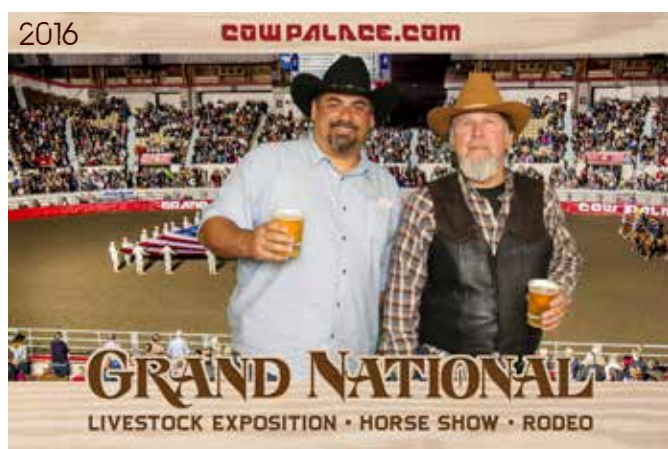

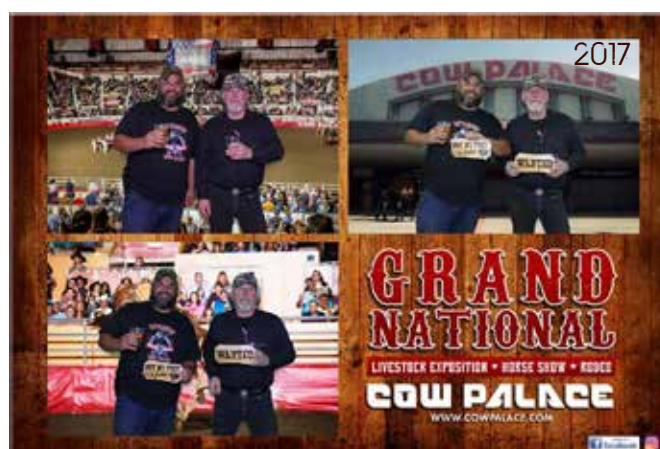

# When Disasters Strike

This month has proven to be a roller coaster of National Disasters from coast to coast, with Sonoma County yet again becoming another victim. As I write this article, I can't think of one person (Friend, RECHOG Member, Family, or Workmate) that has not been touched somehow by the "Fire of the Century." I really wanted to write a Tales from the Redwoods article that was geared to Safety and our Harley's, but because of the fires and the tragedy's or heroic efforts I heard coming from it I wondered "Have we forgotten to teach need to know tasks when an emergency strikes?"



Technology has improved our lives, which trumps any dependency, because the benefits are priceless. Like some of you, I am old enough to remember thirteen inch black and white TVs, vinyl records, and party-line telephones. I also remember cars getting 8 MPG acceptably. While technology has improved our lives, I feel we are becoming more and more dependent upon it. More and more people are relying on information from the Internet, relying on our smartphones, apps, devices, and seeing more and more people becoming isolated from each other because of a false sense of connection, due to social media.

When the power goes out in your neighborhood or home, can you deal with the most common tasks that a button once controlled? Although the Automatic Garage Door has been around for generations, does everyone in the family or household know how to open it when the power goes out? When there is an emergency and you must evacuate the home, is there a clear path or set path? Do you know other routes to evacuate out of the neighborhood? Do you have flashlights at the ready? Knowing how to turn the gas, electrical and water off?

Nobody likes being caught with their pants down, but some how this seems to happen at an unreasonable time. As humans, we are a predictable creature with set routines and habits and we tend not to deviate far from them.

During a firestorm, a house and its contents are just stuff (some being hard or irreplaceable), I get that but life too is irreplaceable. Trying desperately to fight a firestorm to save yours or neighbors house with a garden hose is a David vs Goliath undertaking with real life implications. The fires we had here last week, temperatures at the base would easily be 750 degrees and rising well past 1200 degrees. The amount of water at those temperatures (1/2" x 100' hose, 40 psi,) is 6 gallons per minute (gpm) would virtually dry before putting any flame out and placing yourself in harms way, not to mention that you are taking water psi away from firefighters need for water to help in the evacuation process.

Life is far too important and I am thankful for all of my family, friends, RECHOG friends and members, and workmates who are safe from the fires. But stuff is stuff (which I have found out just last week I have far too much of) and life is far more valuable, so please take the time to see its value.

## It is with difficulty that I submit this months newsletter comments.

Four and half weeks ago I was in a motorcycle accident. And I now find that the older I become, the slower I heal. But the alternatives are worse. Not aging vs. dying. Healing slowly vs. not healing or deteriorating. But being infirmed and inactive and in pain, I find myself irratible and grumpy. Add to this the devastating fires in Sonoma and Napa counties, it is difficult for me to be upbeat, as I write to you.

I will not dwell upon my accident. We share the roadways with inexperienced, inattentive, and distracted drivers. So accidents can and do occur. This is why we have a safety officer in our chapter and we spend as much time as we do encouraging our members to always be vigilant. I should have been more vigilant.

Since I was ambulated to the ER the officer arranged to have my bike towed and stored. This became a problem, since when we tried to have the bike towed to the dealership, the towing company refused to release the bike unless the impound fees were paid upfront. \$365 to "store" my bike outside in the rain, for one night. And HOG membership towing and my insurance towing was not set up to pay upfront and on site! What to do? What friends do I have who have a trailer and would be willing to go pick up my bike and willing to pay \$365 cash? And do I even want to impose upon them?

Solution and Take Home Message: Call Phil Eiselin, our dealer liaison for RecHog, and owner of Sonoma Co. Harley Davidson. Phil arranged to have the bike delivered to his shop, he paid the impound fee for me, and has stored the damaged bike since, for free. Just as he has offered to store any bike, for free, for anyone needing storage due to the fire storm that ravaged our county! Thank You Phil!!!!!!

Now on to reporting the fires: Although the fires are fresh in our minds, and to some of us traumatizing, our newsletters also become our chapter's archives for current and future members.

Monday morning at 2:30am on Oct. 9th, 2017 my cell phone alert message dinged. It said fire warning! Groggy and half asleep, I did not take it seriously. Kind of like an Amber Alert. What do they expect me to do about it at 2:30am? This was shortly followed by loud pounding and door bell ringing at my front door. My wife jumped out of bed, answered it, and was told to get out NOW! I was struggling to get up (I was just in a motorcycle accident. Remember?). When I limped to the front door I stepped outside. A ¼ mile north on the hill was the Fountain Grove neighborhood lit with fire. I could see the flames and the bellowing smoke was glowing bright orange all leaning left to the west. And although it was not coming directly at us, it was still terrifying! And the smoke was heavy. Unprepared for evacuation we grabbed a few things and my wife Caroline and I each drove a car out of there. Leaving her Harley in the garage. My Harley was still being stored at the dealership (Courtesy of Phil. Remember?). But drive to where? Again unprepared. After driving a few miles away, Caroline was following me, I pulled over to read my cell phone for the staged evacuation center. It stated a location. But I had no idea where that was! Then it dawned on me to go to my daughter's house, near Santa Rosa Veterans Memorial Center. We spent the night at her house, not knowing if they might be evacuated also.



We returned home the next day to gather more stuff out of our house. And returned again the next day to get more stuff. We were voluntarily evacuated two more times. But since we still had electricity, but no gas, we stayed in our house glued to the TV reports.

Claude and Shirley Jones had it worse. Even though their house was spared, almost every house just across the street from them was burnt to nothing.

And worse still were Larry Jacobs (RecHog printer & member) and Bill Parker (member) and their families lost their homes completely. There may be more members that I'm unaware of at this time.

The Fires consisted of the Redwood Valley Fire (North of Ukiah), The Pocket Fire (North East of Geyserville and close to Marc Mendelson's home, our activities director), The Tubbs Fire (Calistoga to Santa Rosa), The Atlas Fire (East of Yountville and Napa and South East toward Fairfield), and The Nuns Fire (West of Yountville and down West of Napa) All burning simultaneously, vigorously pushed by winds up to 80mph.

It was the severe wind that created the largest fire storm that California has ever seen. The Tubbs Fire came up from the Napa Valley north into Calistoga. Then west over the Calistoga Rd pass into Santa Rosa. The wind acting like a blow torch across the Fountain Grove district, continuing west taking out the Red Barn Hilton Hotel, jumping the US Hwy. 101, igniting the Coffey Ln. district. The fires moved so fast the first responders couldn't stay ahead of them. Their priority became to get people out, forget about trying to fight the fire.

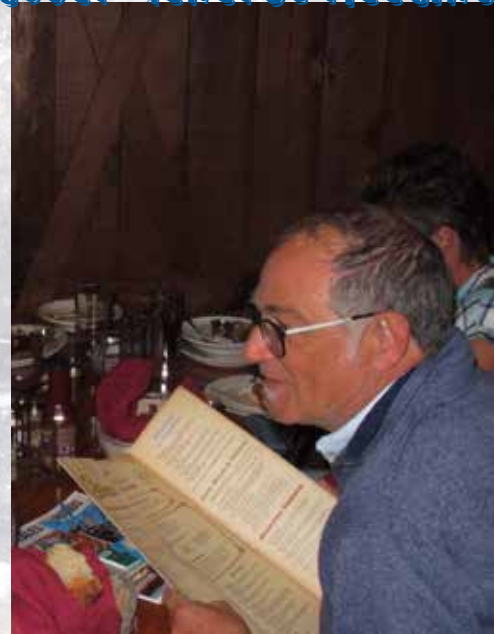
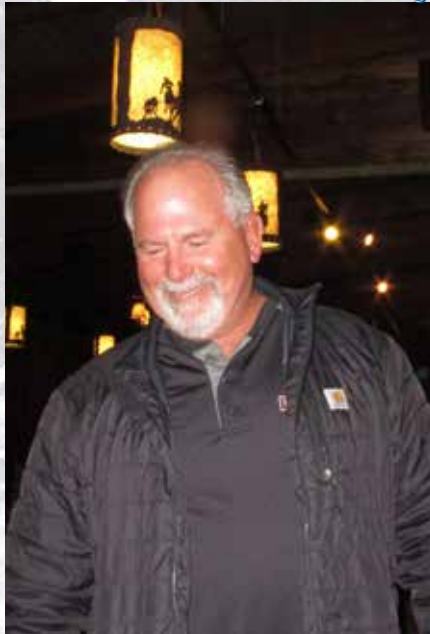
A day or two later the Nuns Fire flared up moving north through Glen Ellen, Kenwood, and Oakmont. The fire fighters and helicopters, now from almost every state in the country returned daily inching on containment. On Thursday Oct. 19th, ten days later, the north bay area got a ¼ to ½ inch of rain. The fire crews started to return home. Some lost their homes to the fire as well. Over 160,000 acres burnt, 42 dead, 6,900 homes and other structures lost.

Shock and Grief following a severe loss affects people at different times and in different ways. Let us all be as supportive as we can to our fellow citizens.

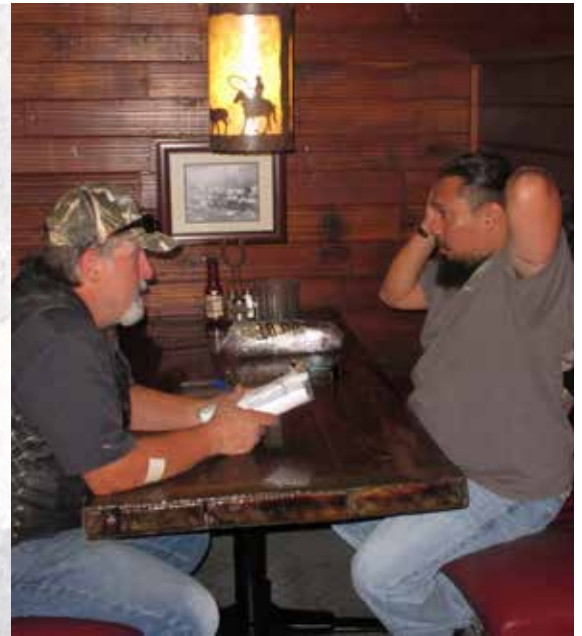




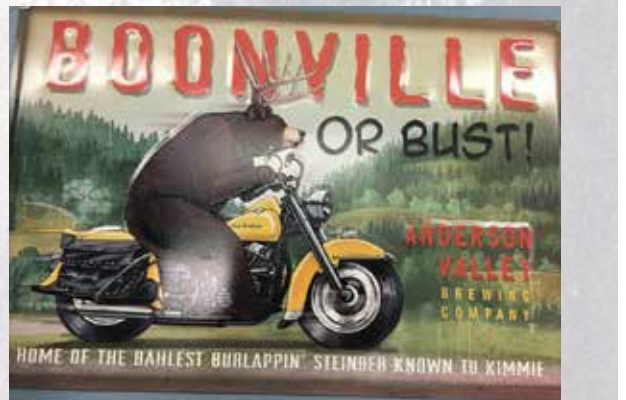
